

## **Fines catalog for punishing violations in the area of the Infection Protection Act (IfSG) in connection with the Saxon Corona Quarantine Ordinance**

In Section 5 of the Saxon Corona Quarantine Ordinance (SächsCoronaQuarVO), the Free State of Saxony determines that violations of the SächsCoronaQuarVO constitute administrative offenses pursuant to Section 73 para. 1a No. 24 in connection with § 30 paragraph 1 sentence 2 IfSG in connection with SächsCoronaQuarVO as punished as follows.

The attached catalog of fines is to be used as a guideline for the responsible administrative authorities in the event of administrative offenses due to violations of the SächsCoronaQuarVO. Framework sentences for the amount of the fines are given in order to achieve uniform enforcement in the prosecution and punishment of violations.

The administrative offenses listed in the catalog of fines relate to the order in public space, so that the public health authorities and the local police authorities are responsible for their persecution and punishment (see § 4 SächsCoronaQuarVO).
